1. 50% down payment upon receipt of contract within **five (5) days**.
2. Full payment to be settled two (2) months before the commencement of the exhibit.
3. If full payment is not received by the organizer by its due date, late interest charges accrue at 3% of the regular booth rate balance per month.

If the Exhibitor wishes to cancel its Exhibition Space, it shall:

- (a) Provide immediate written Cancellation Notice to the Organizer.
- (b) Pay the following cancellation charges, dependent upon the date of receipt of such.

Cancellation Notice by Organizer

1. 50% of the total Fees Paid or payable by the Exhibitor where the Cancellation Notice is received by the Organizer during the period which falls between 180 days and 121 days (inclusive) before the start of the Exhibition.
2. 100% of the total Fees Paid or payable by the Exhibitor where either the Exhibitor does not provide any Cancellation Notice or where the Cancellation Notice is received by the Organizer on or after the date which falls 120 days before the start of the Exhibition.
3. The Exhibitor shall pay the applicable cancellation charges within 30 days of the Exhibitor's Cancellation Notice or within 14 days of the Organizer's invoice for such sums, whichever is sooner.
